TERMS AND CONDITIONS

All sponsors and exhibitors must agree to the following terms and conditions for sponsoring and/or exhibiting at PVC Australia 2026 ('PVC AUS 2026') in Surfers Paradise, Qld. *PVC AUS 2026* is co-ordinated and organised by the Vinyl Council of Australia.

Bookings

Confirmation of exhibition space or sponsorship can only be made upon receipt of a completed 'Booking Form' and payment. Phone bookings will not be accepted. To secure your sponsorship package or exhibition space, full payment or a 50% deposit of the total booking amount must be made upon confirmation of your booking. All sponsorship opportunities are allocated on a first in, first served basis. If you have chosen an option that has already sold, you will be contacted to arrange an alternate option acceptable to your organisation. You will not receive any sponsorship or exhibition entitlements until the first invoice has been paid. Any bank charges arising in respect of Electronic Funds Transfer payments are to be paid by the sponsor/exhibitor and must be included in the amount transferred. Please reference payments as 'PVC AUS 2026'. The balance of the sponsor/exhibitor fee is due by 30th April 2026. Should final payment not be received by the due date, your booking may be offered to another company.

Cancellation

Cancellation of sponsorship or exhibition space must be received in writing. Cancellations received prior to 1st February 2026 will receive a refund of any monies received less a A\$550.00 administration fee. For cancellations received after 1st February 2026, the Vinyl Council reserves the right to retain all monies received unless a replacement sponsor can be found. In the event that *PVC AUS 2026* cannot be held by the Vinyl Council of Australia due to acts of God, government, or other events beyond our control, sponsors and exhibitors will receive a proportionate refund of any monies available after fixed costs have been met. The Vinyl Council of Australia will not be responsible for any further costs incurred by sponsors and exhibitors in connection with the event.

Liability insurance

While every reasonable precaution is taken, the organisers expressly decline responsibility for any loss or damage which may befall the person or property of the exhibitor from any cause whatsoever. Exhibitors/sponsors are advised to take out adequate cover, especially Public Liability insurance. Public Liability insurance is not included in the sponsor/exhibitor package cost. Exhibitors may be asked to provide a certificate of cover from their insurer. You, your employees, and your contractors must conform to the venue's OH&S, insurance and other regulations and may be accepted or rejected at our/the venue's sole discretion. You are solely responsible for any physical loss or damage to your own property.

The Vinyl Council of Australia cannot accept any liability for death, injury, any loss, cost, or expense suffered by any person (including accompanying persons, or partners, or attendant caregivers), if such loss is caused or results from the act, default or omission of any person other than an employee or agent of the Vinyl Council of Australia. In particular, the Vinyl Council of Australia cannot accept any liability for losses suffered by reason of war including threat or war, riots and civil strife, terrorist activity, natural disasters, weather, fire, flood, drought, technical, mechanical or electrical breakdown within any premises visited by exhibitors/sponsors' delegates and/or partners in connection with *PVC AUS 2026*, nor losses suffered by reason of industrial action, governmental action, registrations or technical problems which may affect the services provided in connection with *PVC AUS 2026*.

The Vinyl Council of Australia is not able to guarantee that speakers or panellists as advertised will appear and reserves the right to alter the program or cancel or change event components or substitute services without notice.

Registration

Admittance to the event or exhibition is strictly by name tag only. To take up any included delegate registrations, you must complete a separate relevant form closer to the event. Your application to sponsor or exhibit does not constitute an attendee registration. Your staff will be denied access to the event or exhibition unless they have completed the relevant registration form. All registrations are transferable in full until 72 hours prior to the welcome event.

Artwork and exhibiting

The sponsor/exhibitor is responsible for providing artwork, logos, and text as relevant by the due dates. The Vinyl Council takes no responsibility for publishing artwork, logos, or text after the due date or in an incorrect format. Logos and/or company names will be reproduced in the event colour/s, full colour, or mono, at our discretion. All logos must be at least 300 DPI at 100% in EPS (preferred for print) and JPEG (preferred for website) format. No print or web recognition will be given unless payment terms have been met.

You have limited licence to exhibit. You may not assign, share, sub-let, or grant licences for the whole or part of the tabletop display without our prior approval. The Vinyl Council reserves the right to ask you to remove any display items it deems as unacceptable. You must conduct business only from within the confines of your tabletop display space. You may not tout, or place any material, outside your tabletop space causing obstruction of the aisles. You will be responsible for any reasonable costs of repairing the booth or premises should you paint, mark, or damage any fixtures or fabric. You must familiarise yourself with the venue's terms and conditions prior to the exhibition date. Food, beverage or prohibited items are not permitted at the event unless prior arrangements are made with the organiser.

Privacy statement
